

### 2025 Old Trail Swim Club Pavilion Rental Application

#### **PAVILION RENTAL GUIDELINES**

- The covered Pavilion may be reserved for group gatherings and celebrations
- Private Event reservations of the entre swim facility are permitted on a case-by-case basis and inquiries should be sent to social@oldtrailclub.com.
- 5 days' notice at a minimum
- Rental is for up to 3 hours (You may arrive 45 minutes early for set up and 45 minutes after for clean-up)
- The guestlist is due at least 3 days before the date of the party and is to include ALL adults and children attending
- Renting member must be at least eighteen (18) years of age and be present for the entire rental period.
- Once the party time is over everyone from the party must leave or the booking member will be responsible for the appropriate usage fee for each person who stays.
- Located below are the Pavilion Rental Rates:

#### Parties with fifteen (15) or less people:

**Member:** \$225 + \$25/Extra Hour **Non-Member:** \$300 + \$35/Extra Hour

• Maximum: 15 people in total whether they are swimming or not

### Parties with more than (>) fifteen (15) people and no more than thirty (30) people:

**Member:** \$300 + \$40/ Extra Hour **Non-Member:** \$375 + \$50/ Extra Hour

• Maximum: 30 people in total whether they are swimming or not

#### Parties with more than (>) thirty (30) people and no more than forty-five (45) people:

**Member:** \$375 + \$40/ Extra Hour **Non-Member:** \$450 + \$50/ Extra Hour

• Maximum: 45 people in total whether they are swimming or not

#### Parties with more than (>) forty-five (45) people and no more than sixty (60) people:

**Member:** \$450 + \$40/ Extra Hour **Non-Member:** \$525 + \$50/ Extra Hour

• Maximum: 60 people in total whether they are swimming or not

#### Private Pool Rental: for pricing email social@oldtrailclub.com

- 14 days' notice at a minimum
- Rental is for up to 3 hours (You may arrive 45 minutes early for set up and 45 minutes after for clean-up)
- Hours of private rental: Between 7pm 10pm or 9am-12pm
- Payment due at booking

Club Management reserves the right to refuse entry to large groups that have not provided proper notice. The Pavilion should be left in the same condition that it was prior to the rental period. Any excessive cleanup efforts on behalf of Club Management resulting from a Pavilion rental will result in a \$100 charge to the Member's account.
